## NATIONAL COMMISSION ON LABOUR

The third meeting of the National Commission on Labour was held in the committee room of the Employers Federation of India, Army and Navy Buildings, 148, Mahatma Gandhi Road, Bombay-1 on the 6th May, 1967. The following were present:

Shri S.A. Dange, Shri B.C. Ganguli, Dr. B.N. Ganguli, Shri N.K. Jalan and Shri-Raja Ram Shastri regretted their inability to attend the meeting. The following decisions were taken:

- (i) The conclusions of the second meeting of the Commission held on 11th March, 1967 should be confirmed.
- (ii) A Minute Book should be maintained in the Commission for recording the decisions arrived at in the meetings of the Commission. Accordingly the decisions of the meeting held on 18th January, 1967 and 11th March, 1967 were-recorded in the Minute Book under the signature of the Chairman.

- (iii) The progress of the work done in the Commission was noted. This included (a) the setting up of the Secretariat of the Commission; (b) the appointment of technical staff; (c) arrangements for hiring additional accommodation; (d) issuing of the questionnaire- about 12,000 copies already distributed; (e) discussions with the liaison officers of Central Ministries; (f) meetings of Member-Secretary with State Liaison Officers at State headquarters; (g) liaison with the International Labour Office; and (h) liaison with the Labour Advisers/Attaches of Embassies/High Commissions located in Delhi.
- (iv) Note was also taken of the meeting which the Gommission was holding with the Liaison Officers of State Governments in Delhi on 11th May, 1967. The items of discussion in the letter sent by Member-Secretary to the State Liaison Officers were approved. Member-Secretary had sought information from the State Liaison Officers about (a) names of persons to whom the questionnaire should be sent; (b) places of importance which the Commission should visit; (c) names and addresses of persons to whom the Commission should meet during such visits; (d) 5 or 6 districts which could be considered representative of small industries/ agricultural labour; (e) names of industries likely to be set up in the States in the years to come; (f) reports on special studies undertaken in the States on-labour problems; (g) difficulties experienced in implementing specific provisions of labour laws; (h) services of State officials for help in the work of Study Groups, and so on.
- (v) Since a fair number of public sector liasion officers were located in Delhi, Bombay, Bangalore and Ranchi, meetings with officers similar to the one proposed to be held with State Liaison Officers should be convened at these 4 places.

- (vi) In pursuance of (iv) (b) and (c), Member-Secretary should draw up a tentative programme of visits to the States for being placed at the next meeting of the Commission.
- (vii) Agenda items 2 and 3 were taken together for discussion because of their inter-connection. After receiving a report from Member-Secretary of the work done by the Study Groups already set up and the suggestions which the members made about the preliminary reports on coal, iron and steel, and fertiliser premared in the Secretariat, the suggestion about the setting up of industry-wise study groups was agreed to.
- (viii) The subject-wise study groups should also be set up simultaneously.
- (ix) The industries which were selected for the setting up of study groups should be classified according to some standard classification from the point of view of similarity of labour conditons. This would help making arrangements for the chairmen of allied study groups getting together for exchanging notes.
- (x) For the classification as in (ix) above, Dr. Baljit Singh and Member-Secretary should get together.
- (xi) After a discussion on the personnel of the study groups, a sub-committee consisting of Dr. Bharat Ram, Shri Kotwal, Shri Ramanujam, Shri Tata and Member-Secretary was constituted to finalise the personnel of different study groups (Report of the sub-committee is appended).
- (xii) The Study Groups should normally consist of about 7 to 9 members. The Secretary should be an officer of the status of Deputy Labour Commissioner in the State.
- (xiii) The next meeting of the Commission will be held in Hew Delhi on 8th July, 1967.
